Video and Statistics

- Applicants must submit to each member of the selection committee the following:
- Statistics for your dog from the last 4 trials in which s/he competed (before making this application – **Jumpers and Standard rounds only**).

Include:

1. Level of course
 2. Length of course
 3. SCT
 4. Results (Time, Clean or list specific faults)
 5. Date and Location
- Video clips of your dog in **DVD format only** showing your dog's runs (no other dogs and no award ceremonies) Breaks inserted between each clip and each clip labelled either on screen or on paper.
 - i) Include your dog working at the FCI jump height for which you are applying. If your dog does not compete at this height regularly, videos of training sessions are acceptable but should be at a level of difficult that would be required at an excellent level.
 - ii) Clips must show Jumpers/Jumpers with Weaves/ and Standard runs only. (No games). Course maps should be sent if available. Please include 4 runs (2 jumpers and 2 standards). These must be at a recent trial (within 4 months of the prior to the application). Preferably CKC Excellent courses.
 - iii) Any International or FCI events courses may be included at the end.
 - Provide obstacle times for: weave poles, teeter, dogwalk, table and A-frame.
 - List any health concerns your dog has and treatments used.
